e-shelter plans, designs and operates high-availability data centers. The subject of evaluation are the corporate divisions e-shelter services GmbH, e-shelter facility services (Schweiz) AG and e-shelter facility services (Austria) GmbH (further called „e-shelter services“) for the locations Frankfurt (D), Rüsselsheim (D), Berlin (D), Unterschleißheim (D), Rümlang (CH) and Vienna (A). The core task is the technical operation of high-availability data centers. For this purpose all necessary networks, applications, rooms and buildings are considered, which represent the basis of the business processes of a technical facility management in their entirety.

The subject of certification stated above was audited by Alexander Göbel, certified Auditor for ISO 27001 audits in compliance with IT-Grundschutz, in accordance with the certification scheme of the German Federal Office for Information Security (BSI). The conclusions drawn by the certified Auditor and included in the audit report correspond with the evidence given.
